LAUNCHING CITIZENS' PROTEST DEMONSTRATION IN FRONT OF D.C. OFFICE, KOKRAJHAR
ON DEMAND OF STOPPING BRUTAL KILLING OF INNOCENT PEOPLE BY EXTREMISTS

Hon'ble Home Minister Sir,

With due honour and respect we the undersigned of Bodo Sahitya Sabha, the pioneer and sole National Organization of Language, Literature and Culture of Bodo Community along with other allied organizations are willing to convey the following matters to your honour through the Citizens Protest Dharna Programme.

Hon'ble Home Minister Sir, it is to your honour's knowledge that on 23/12/2014 in the evening time, the suspected N.D.F.B.(S) suddenly killed about eighty Adivasi people including women and children in village Serphanguri, Pakriguri, Ultapani, Sorapara, Kharigaon of Kokrajhar District of BTAD and Batachipur under P.S. Dhekiajuli and Phulbari under P.S. Biswanath Chariali of Sanitpur District of Assam. In the event of such odd incident due to misunderstanding the miscreants availed opportunity to burn down the houses of Bodo and Adivasi communities with loss of lives of some people too. On the moment of receipt of this incident, the Bodo Sahitya Sabha and National Organizations reacting strongly and condemned such brutal killing along with demand to the Govt. of India for taking necessary strong measure to stop such inhuman killing by the N.D.F.B.(S) Group.

We are immensely pleased that on receipt of information of such undesirable event, the Hon'ble Prime Minister of India Sjt. Narendra Modi immediately instructed the responsibility to your honour as Union Home Minister, Union Tribal Affairs Minister Sjt. Juwel Oran and Sjt. Kiren Rijiju, the Hon'ble State Union Home Minister of India to visit the trouble torned areas and to take all preventive measures.

We are also pleased to appreciate your honour for your immediate arrival to Assam on 24-12-2014 and thereafter to discuss the situation with His Excellency, the Governor of Assam and Hon'ble Chief Minister of Assam.

Thereafter on 25th December, 2014 your honour was pleased to visit Biswanath Chariali of Sanitpur District and Kokrajhar District of BTAD to discuss ways and means to control the situation with District Authority and other representatives of affected communities.

We are also appreciating to your honour to see the immediate strong decisive steps taken by the Union Home Ministry to control the tense situation prevailing between Bodo and Adivasi communities. As a result, the normalcy is prevailing gradually. But it is Strongly deemed necessary for taking positive steps immediately in the following matters-

1. To take very strong and effective measure to stop all kind of the brutal killing...






- innocent people by NDFB(S) and other extremists group like- ULFA(I), KLO. JMB Jehadi operating in Assam.
2. To post permanent Security Force in Assam-Arunachal and Indo-Bhutan Border and affected areas.
 3. To release immediately ex-gratia grant of Rs. 5,00,000/- declared by the State Govt. of Assam and Rs. 2,00,000/- by the Central Govt. of India to the kid and kin of deceased persons.
 4. To extent ex-gratia grant of Rs. 10,00,000/- for construction of dwelling house to the affected families of trouble torned areas.
 5. To provide food materials along with baby food, warm cloths, drinking water facilities, free medical treatment to the affected people sheltering in relief camps till time of their complete rehabilitation.
 6. To take necessary steps to construct road and bridges for free and convenient movement to the interior places of Border areas with a view to control the activities of the extremists.
- In the above matters, we earnestly pray your honour with strong urge to instruct the State Govt. of Assam for taking fruitful measures with immediate effect.


