**DEMANDING THE STERN ACTION AGAINST MUSLIM**  
**FUNDAMENTALIST ORGANISATIONS OPERATING IN BTAD, ASSAM.**

**Most respected Sir,**

We, the undersigned, on behalf of the Bodo Sahitya Sabha have the honour to lay down before you the following few lines for favour of your kind attention and immediate necessary action.

That Sir, some Muslim fundamentalist organizations like Al-Qaeda, JMB etc. have been active in Assam, particularly in Bodoland Territorial Area District (BTAD) since some years back have been a cause of terror among the people living therein. These organizations have been trying to destabilize the social fabric by creating communal violence among the different Communities and religious groups. Having been apprehensive about the aftermath of such social violence being let loose by these fundamentalist organizations, the Bodo Sahitya Sabha apprised the Govt. of India through a Memorandum submitted to the Hon'ble Prime Minister after staging a Mass Dharna at Jantar-Mantar, New Delhi on 26<sup>th</sup> November, 2014. 


of regret is that, no proper action has been taken up in this regard so far. Proving our apprehension correct, the Jehadi-activities by the aforesaid Muslim fundamentalist organizations have been growing alarmingly very recently in Assam particularly in BTAD. For instance, as many as seven jihadis belonging to the JMB including one Imam of Rajapara Jamme Masjid Joynal Abedin were arrested in the Amguri Area of Chirang district under BTAD, Assam by the security Personnel on 21/4/2016 while taking shelter in the Masjid. Again, on 23/4/2016, a jihadi named Abdur Rouf belonging to a newly floated jihadi organization - Muslim United Liberation Tiger Force of Assam (MULTFA) was arrested at Mankachar near Dakshin Salmara under Dhubri District of Assam. It is learned through media that, he underwent arms training in Bangladesh and very recently was indulging in extortion bid among the local businessmen.


Thus the overall situation in Assam and particularly in BTAD, so far as the jihadi activities are concerned, is very volatile. We are apprehensive enough that the jihadi Organizations Stated above may create communal violence at any moment in days to come, thereby destabilize the social peace and communal harmony among the people living in the region in question, unless these forces are dealt with sternly.


