Respected Madam,

We, the undersigned, for and on behalf of Bodo Sahitya Sabha, would like to extend our thanks and gratitude for introducing Elective Course in Bodo under your esteemed University. But, at the same time, we also express our regret for not conceding other demands till date.

That Madam, the Bodo Sahitya Sabha had submitted Memorandum for two times before the then Hon'ble Vice-Cancellor on 26th November, 2008 and on 23rd April, 2010 at the office chamber of the V.C, Assam University, Silchar. During the course of discussion, he had committed to concede all of our demands from the academic Session of 2009-10 and Minute was also drawn to that effect and it was clearly mentioned in the Minutes of the 2nd discussion that the Academic Council of the University has taken decision to introduce Major Course, but not translated into action till date. Only the Elective Course was introduced in TDC, Vide Notification No. AUD-107/2010/2629 Dated 4th October, 2010, others remained unfulfilled.

Madam, you are aware of the fact that, as per provision provided under Article-21(A) of the Constitution of India, Education has been brought under Fundamental Right after 86th Amendment in 2002. Further, Article-46 also provided provisions of promotion of Educational and Economic interest of the Scheduled Caste, Scheduled Tribes and other weaker sections of people.

But Madam, we feel that, Bodo language has been neglected and received no due importance and hence, still, our demands remained unfulfilled and the students who have passed out have been deprived every year from Higher Education by getting admission neither in the Guwahati University nor in the Bodoland University. Had it been introduced Major course and MA department under Assam University, some of them could have been accommodated according to availability of seat. Let us cite the present enrolment position in the subject - BODO in different Colleges under Assam University.




Therefore, we request your honor to take appropriate measure of introducing the following Courses and Department under your University -


- (1) MAJOR COURSE IN BODO
